



## **MATERIAL EVENT NOTICE**

### **NEBRASKA INVESTMENT FINANCE AUTHORITY HOMEOWNERSHIP REVENUE BONDS**

Due to the downgrade of the United States Government by Standard & Poor's from "AAA" to "AA+", the long-term credit rating of the Homeownership Revenue Bonds issued by the Nebraska Investment Finance Authority pursuant to that General Indenture of Trust, dated as of December 1, 2009, as amended and supplemented, also has been downgraded by Standard & Poor's from "AAA" to "AA+".

The rating change impacts CUSIP number 63967RAA7.
